Mungo National Park

Today we meet our locally based guide for our visit to the World Heritage listed Mungo National Park. The Willandra Lakes preserve the longest continuous record of aboriginal life in Australia from 40,000 years ago to the present. Our tour across the lake floor to the "Walls of China" provides an opportunity, via the layers of the sand dunes, to experience the history of this pre historic period. The tour slowly and gently weaves through unique geological formations of rare beauty passing by the ancient evidence of the people that once walked this land. Lunch is at the Mungo Lodge Restaurant. After a great day we return to Euston to share our stories of the day.

Day 5 — Saturday 19 June Mildura to Sea Lake

Today is all about Silo Art. Providing an insight into the true spirit of the Wimmera Mallee, the trail recognises and celebrates the region's people through a series of large-scale mural portraits painted onto grain silos, many of which date back to the 1930s. The project saw a team of renowned artists from Australia and across the world visit the region, meet the locals and transform each grain silo into an epic work of art. Each one tells a unique story about the host town. The size cannot truly be appreciated until we are looking directly at the silo. It is not only the size but the shape of a silo that presents unique challenges for the artist.

At Patchewollock it is hard to miss the 35m high "silo man" painted by Fintan Magee. At Lascelles, Melbourne artist Rone has painted a local farming couple that has lived in the area for four generations. Hopetoun is next for lunch at the local Community Hotel. The afternoon we visit silos at Rosebery and Brim. We arrive at the small town of Sea Lake and check into our accommodation. We meet a passionate local for a tour of the Lake Tyrell area at sunset listening to stories of interest about the sights.

We farewell our hosts and head to The Lake Boga Flying Boat Museum where we enjoy a self-guided tour and morning tea. The museum is a memorial to those who worked on and with the Flying Boats during World War II and particularly commemorates the contribution made by service men and women stationed at the No. 1 Flying Boat Repair Depot. The Lions Club, after many hundreds of volunteer hours, rebuilt the aircraft, the famous Catalina A24-30 on display today and has re-constructed the adjacent Communications Bunker using original plans and photographs, to resemble its wartime state. Lake Boga was an ideal stretch of water on which the mighty flying boats could alight. Continuing on we arrive at the Deniliquin RSL Club for lunch. Sit back and relax, maybe bring a good book onboard as we travel through to Wagga Wagga.

PRICES & EXCLUSIONS

Prices stated ere in Australian Dollars (\$AUD), include GST and are current at the time of publication. The price includes transportation, accommodation and inclusions as per the published itinerary.

PRICE SURCHARGES
