Take a little time to wander the Beechworth Historic and Cultural Precinct including The Telegraph Station and Town Hall. We visit The Kelly Vault that houses the original Ned Kelly's death mask, Ned Kelly's gun named Betty, Brother Dan Kelly's pistol and the original table from the verandah of the Anne Jones Hotel. Returning to Albury we visit Schmidts Strawberry Winery. We enjoy a tasting of the strawberry wine as it is truly delicious. The wines are made using a traditional family method, available in dry, semi-sweet or sweet.

We commance providing services to you as soon as we accept your booking. This includes (often significant) work undertaken prior to travel to amange and coordinate the dalwary of your travel arrangements.

### PRICES & EXCLUSIONS

Prices stated are in Australian Dollars (\$AUD), include GST and are current at the time of publication. The price includes transportation, accommodation and inclusions as per the published Rinerary.

Domestic airfares and airport/hotel transfers are not included unless specifically stated. Costs associated with insurance, meals (other than those stipulated), emergency medical costs, gretuities, and all items of a personal nature are not included.

#### PRICE SURCHARGES

### **CANCELLATIONS BY YOU**
